

**Delinquent Balance Due**

Franklin County will allow former owners or their heirs to bid in the auction provided their minimum bid is at least the delinquent tax, penalty, fees and interest due at the time of auction. If their high bid is less than the amount owed, Franklin County will convert the bid amount to the Delinquent Balance Due or if the former owner or their heirs choose not to accept this amount, the property will be offered to the second high bidder.
